5.1.1 Least Restrictive Sanctions for Alcohol & Drug Violations

Notice to Students

Dear Students,

Welcome to the University of Arkansas and the 2008-2009 academic year. Included below for your review are the new "Least Restrictive Sanctions" for alcohol and drug violations of the Code of Student Life. Please take a few minutes to familiarize yourself with them.

All students found in violation of the Code of Student Life for the consumption/possession of alcoholic beverages and/or the use/possession of drugs or drug paraphernalia on or off the University of Arkansas campus will be held, at minimum, to these "Least Restrictive Sanctions". As a student at the University of Arkansas, we ask that you strive to meet the Principles of the University and not only adhere to the Code of Student Life, but embrace its intent to enhance our community. The Code of Student Life is also designed to ensure your safety and to allow staff members to comprehensively and collaboratively respond to situations involving the use, abuse, or possession of alcohol and drugs. Our intent is to ensure that the response to those involved in the illegal and inappropriate consumption/possession of alcohol and drugs is fair, consistent, educational, and timely.

LEVEL 2a

- 2nd Minor Alcohol Violation w/ No Associated Charges
 1. Required participation in the Student Assistance Program (SAP)
 2. Cost of the program
 3. Parental Notification (under 21)
 4. Community Service (50 hours)
 5. Suspended Parking Privileges for one (1) year
 6. 1 Year Probation
 7. Educational Fund Payment (\$200)
 8. Restitution (if applicable)
- 1st Minor Alcohol Violation w/Associated Charges

LEVEL 2b

- 1st Major Alcohol Violation w/ No Associated Charges
 1. Mandatory Alcohol/Drug Assessment by a professional mental health practitioner (licensed or certified by the State of Arkansas). The selection of the practitioner is the choice of the student.
 2. Must comply with the prescribed course of treatment or submit rationale to the contrary for review.
 3. Cost of Assessment
 4. Parental Notification (under 21)
- 1st Minor Minor Drug Violation
 5. Community Service (50 hours)
 6. Suspended Parking Privileges for one (1) year.
 7. 1 Year Probation
 8. Educational Fund Payment (\$200)
 9. Restitution (if applicable)

LEVEL 3

- 3rd Minor Alcohol Violation w/ No Associated Charges
- 2nd Minor Alcohol Violation w/Associated Charges
 1. One Year Immediate Suspension
 2. Mandatory Alcohol/Drug Assessment by mental health professional
 3. Must comply with the prescribed course of treatment or submit rationale to the contrary for review
- 2nd Major Alcohol Violation w/ No Associated Charges
 4. Cost of Assessment
 5. Parental Notification (under 21)
 6. Community Service (100 hours)
 7. Loss of Parking Privileges
 8. Probation until graduation upon return
 9. Educational Fund Payment (\$300)
 10. Restitution (if applicable)
